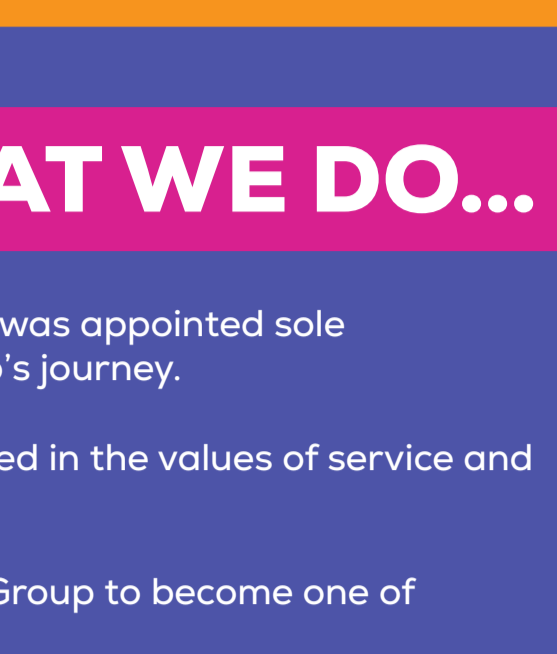

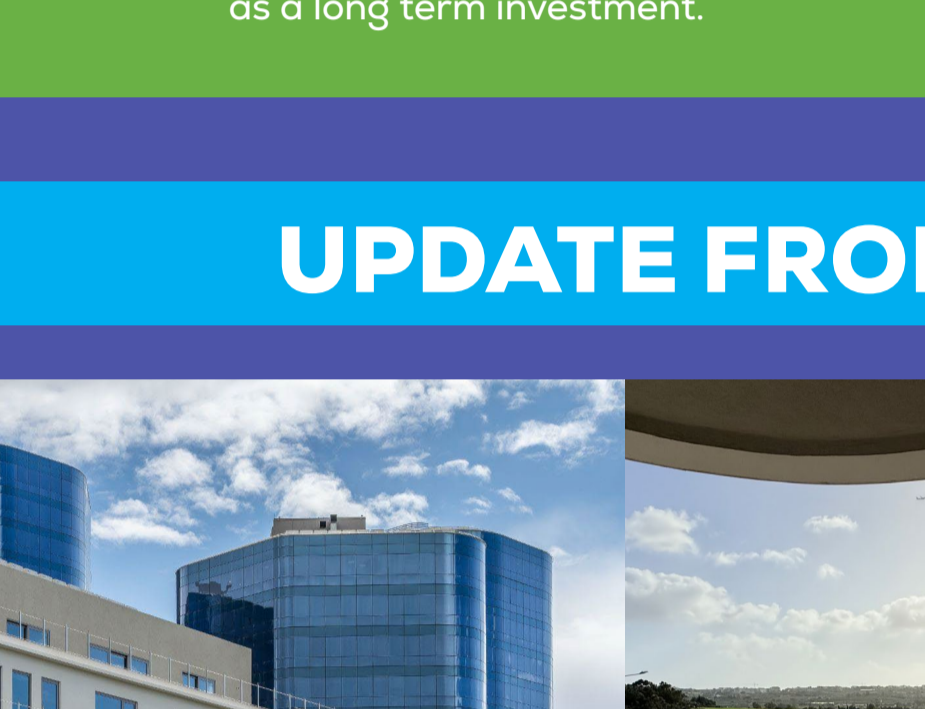

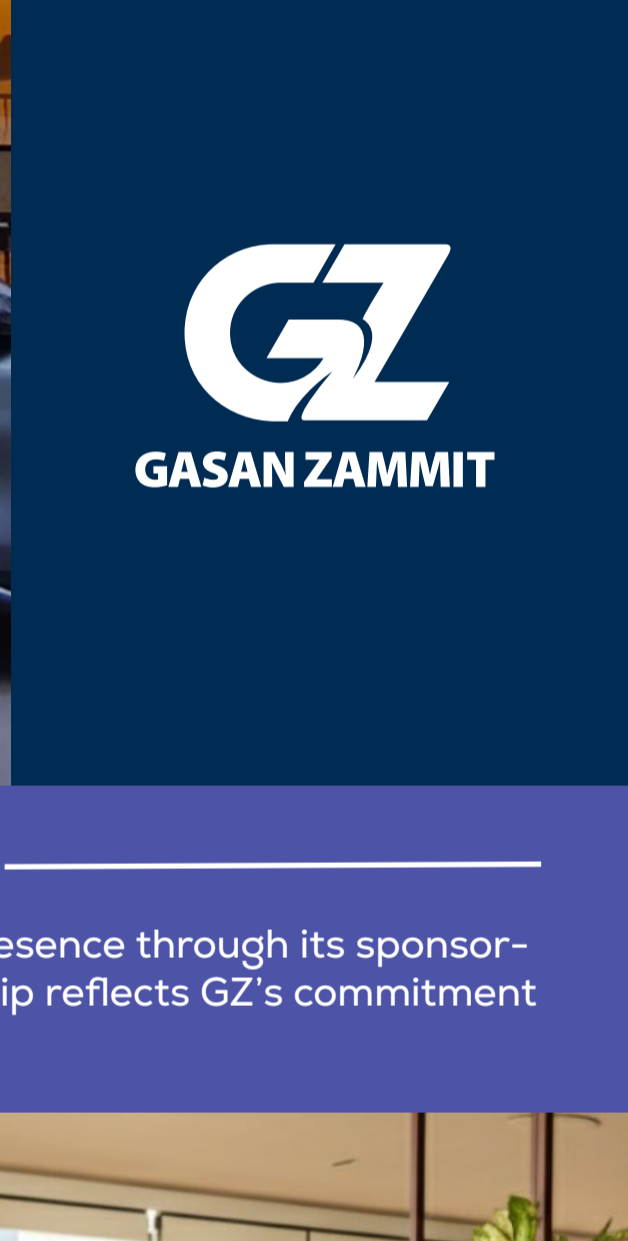
### LEGACY BUSINESS CENTRE

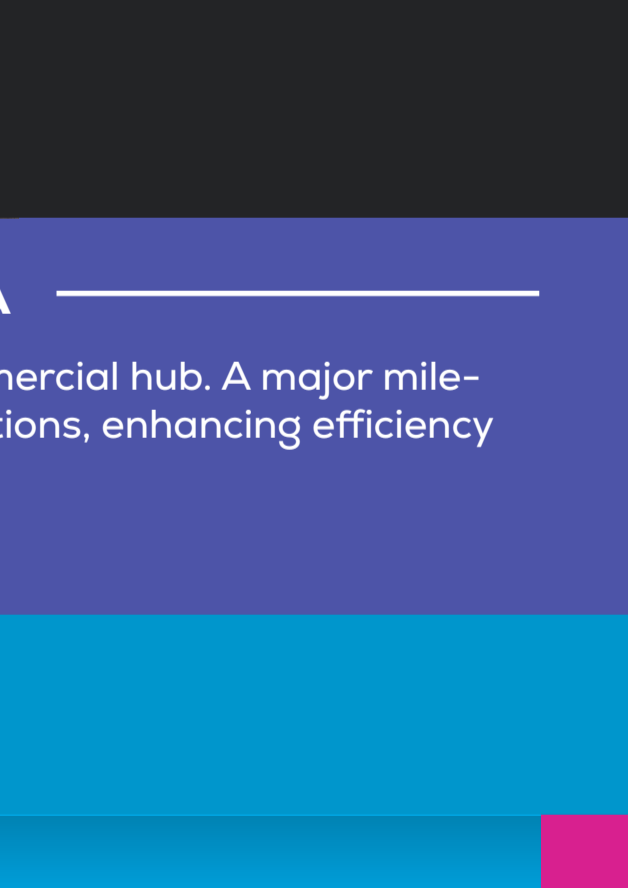
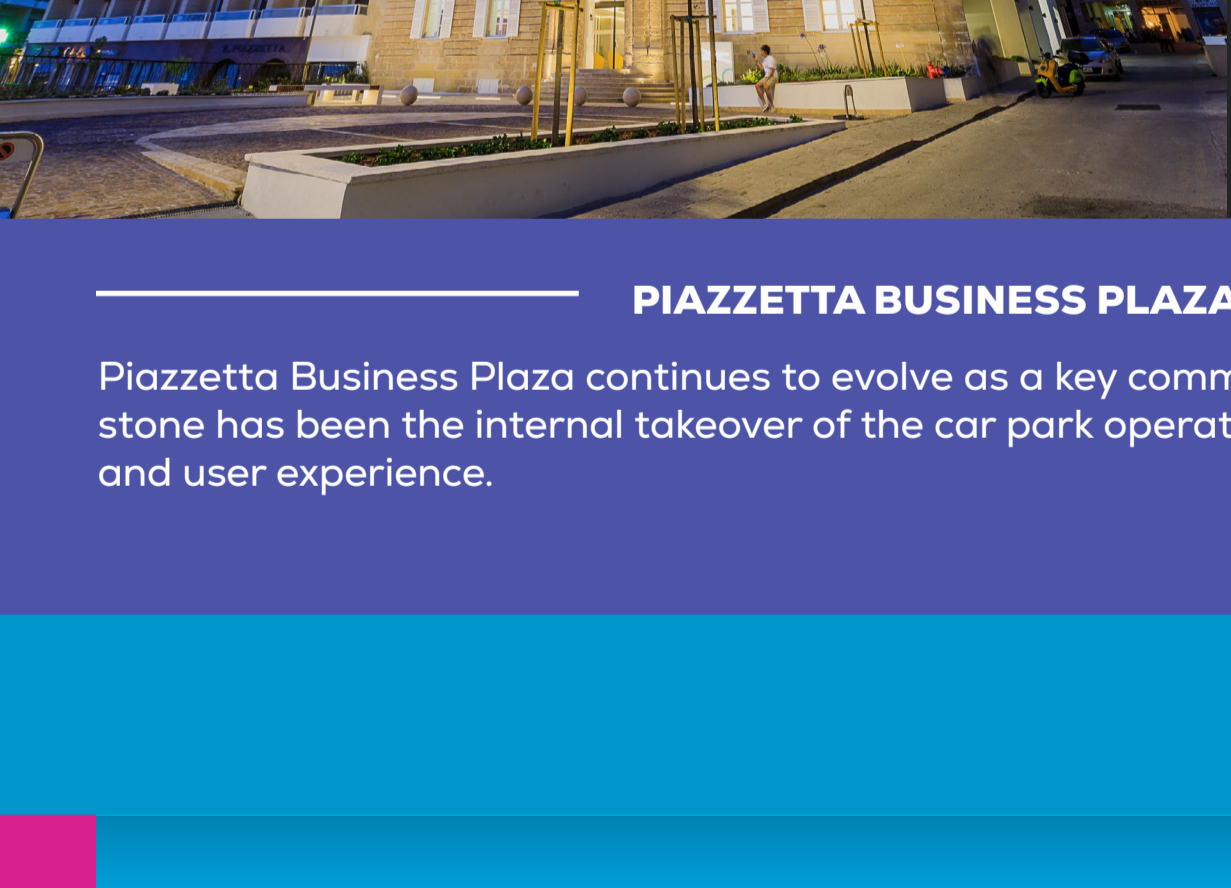

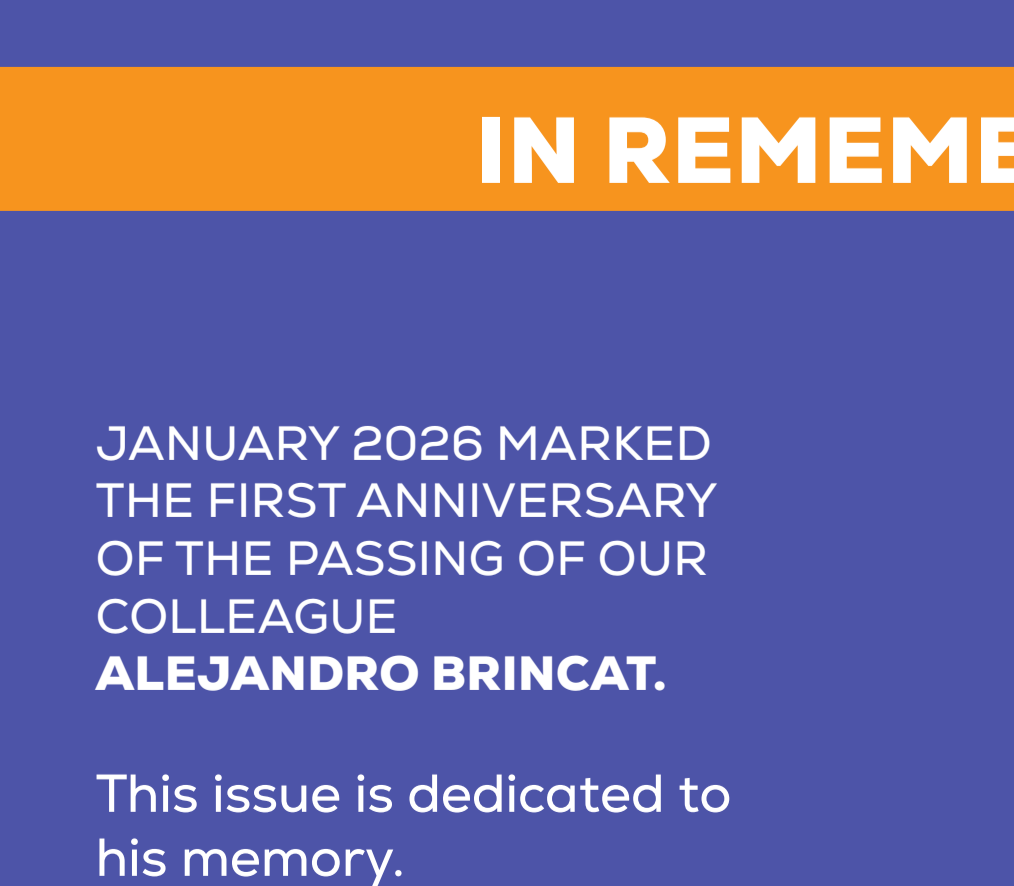
